SECOND AMENDMENT

to

AGREEMENT

between

BRANCH BANKING AND TRUST COMPANY ("BB&T")

and

WEST VIRGINIA STATE TREASURER'S OFFICE ("STO")

This **SECOND AMENDMENT** ("Second Amendment") is made effective February 2018, and amends the Agreement dated October 5, 2016, ("Agreement), known as **AMASTO170000002** by and between **BRANCH BANKING AND TRUST COMPANY** ("BB&T") and the **WEST VIRGINIA STATE TREASURER'S OFFICE** ("STO").

WHEREAS, BB&T and the STO entered in the Agreement referenced above for certain banking services; and

WHEREAS, the parties desire to amend the Agreement to provide clarification regarding 5.2.2.3 of the Request for Proposal response.

NOW, THEREFORE, THIS AMENDMENT WITNESSETH:

The parties covenant and agree as follows:

1. Clarification: With regard to 5.2.2.3 of the RFP and corresponding response, the language should be updated to the following:

"Vendor must allow for the direct presentation of daily check deposits by the STO and the West Virginia State Tax Department to be sent to the Federal Reserve. The Bank will pay all associated charges by the Federal Reserve and the "flow through costs." The STO will in turn pay the "flow through costs" as part of the monthly invoicing." (emphasis added)

BB&T shall provide the services described as clarified.

- 2. Remaining Terms and Conditions: This Second Amendment constitutes the entire understanding and agreement of the parties with respect to the subject matter and supersedes all prior agreements, written or oral, between the parties with respect thereto. All other terms and conditions of the Agreement, as amended, shall remain in full force and effect.
- 3. Execution in Duplicate: This Second Amendment may be executed in duplicate, each of which shall be considered an original.
